## THE PERFORMANCE CHALLENGE FUND'S PROJECT IMPLEMENTATION TEAM (PCFPIT)

WHEREAS, the Municipality of Baliwag has earned the Seal of Good Local Governance and was recognized by the Department of Interior and Local Government as an outstanding municipality who passed the seven criteria namely: financial administration, disaster preparedness, social protection, public order and public safety, business friendliness and competitiveness, environmental management and tourism, arts and culture.

WHEREAS, the Department of Interior and Local Government has established the Performance Challenge Fund; an incentive award given to LGUs that passed the Seal of Good Local Governance:
