ADMINISTRATIVE ORDER NO. 002 S. 2021

AN ORDER CREATING A TECHNICAL WORKING GROUP (TWG) THAT WILL STUDY, RECOMMEND AND IMPLEMENT THE TEMPORARY RELOCATION OF EXISTING STALLS WHILE THE NEW BALIWAG PUBLIC MARKET AND BALIWAG PUBLIC TRANSPORT TERMINAL AND PARKING IS BEING CONSTRUCTED

WHEREAS, Republic Act No. 7160, otherwise known as the “Local Government Code of 1991”, Section 17 (b)(2)(ix), states that an LGU shall exercise such other powers and discharge such other functions and responsibilities to efficient and effective provisions of basic services such as public markets, slaughterhouses and other municipal enterprises;

WHEREAS, for the Municipality of Baliwag to better serve its constituents thru infrastructure projects like the construction of a new public market, there is a need for a Relocation Plan for existing stall owners who shall be affected by the construction to continue on with their business;

WHEREAS, there is a need to create a Technical Working Group (TWG) that will study, recommend and implement the temporary relocation of existing stalls while the New Baliwag Public Market and Baliwag Public Transport Terminal and Parking is being constructed;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Baliwag, Bulacan, by virtue of the powers vested in me as Mayor, do hereby order the creation of a Technical Working Group (TWG) that will study, recommend and swiftly implement the temporary relocation of existing stalls taking into consideration the convenience, safety, sanitation, traffic and orderliness while the New Baliwag Public Market and Baliwag Public Transport Terminal and Parking is being constructed.

Section 2. Duties and Functions.


1. Conduct meetings in pursuit of the objectives of the creation of this TWG;
2. Prepare a Relocation Plan for the temporary relocation of market stall owners while the New Baliwag Public Market is being constructed;
3. Implement the Relocation Plan taking into consideration the safety, orderliness, traffic and sanitation of the temporary market;
4. Prepare monitoring reports of the progress and needs of the implementation;
5. Other tasks necessary and desirable in the full implementation of the program.

Section 3. Repealing Clause. All orders issued and/or parts thereof contrary to or inconsistent with the provisions of this order are hereby repealed, modified or amended accordingly.

Section 4. Separability Clause. If any section or part of this Administrative Order is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.


Section 5. Effectivity Clause. This order shall take effect immediately upon signing hereof and remains effective and binding unless revoked, repealed or modified.
