ORDER CREATING THE EMERGENCY RESPONSE TEAM OF THE MUNICIPAL GOVERNMENT OF BALIWAG PURSUANT TO EXECUTIVE ORDER NO. 44 S. 2016

WHEREAS, the Municipality of Baliwag has created an Executive Order establishing an emergency response mechanism for the Municipality of Baliwag which primary function is to develop response protocols on different types of emergencies and develop expertise and competency of the Disaster Risk Reduction Management members, schools, private sector, and other stakeholders in the community;

WHEREAS, to comply and implement the provisions of Executive Order no. 44. S.2016 of Baliwag, there is a need to reorganize the Emergency Response Team of the Municipality who will be trained and spearhead the implementation of the Emergency Response Mechanism in the local government;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor of the Municipality of Baliwag, Bulacan by virtue of the powers vested in me by law do hereby order:

SECTION 2. PURPOSE.

- A. Develop policies, guidelines, plans and programs to prevent and mitigate emergencies;
- B. Formulate guidelines to define the rules of engagement, procedures, coordination and sharing of resources and responsibility;
- C. Organize and coordinate all sectors for preparedness on emergencies;
- D. Provide the technical assistance and capability development;
- E. Integrate emergency preparedness plan on all sectors; and
- F. Other duties necessary in the effective implementation of the Administrative Order.

The Emergency Response Team shall be trained by the Municipal Disaster Risk Reduction Management Office on Emergency Response procedures and prepare the Municipal Disaster and Emergency Preparedness Plan.

SECTION 2. REPEALING CLAUSE. All previous executive orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly.

SECTION 3. EFFECTIVITY CLAUSE. This order shall take effect immediately.
