**ADMINISTRATIVE ORDER NO. 004 S. 2019**

**CREATION OF THE HOLY WEEK INTER-AGENCY COMMITTEE 2019**

**WHEREAS**, Section 16 of the Local Government Code states that every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. The local government shall also ensure and support the preservation and enrichment of culture, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

**WHEREAS**, the Municipality of Baliwag takes pride for being the home of the longest Lenten Procession in the country with over 100 carrozas participating every year with over a thousand tourists visiting to witness and participate in the different Church activities;

**WHEREAS**, there is a need to create a committee that will spearhead the planning and execution of different programs and activities for an organized, peaceful and meaningful observance of Holy Week activities from April 14, 2019 to April 21, 2019;

**NOW THEREFORE**, by the powers vested in me by law, I, **FERDINAND V. ESTRELLA** Municipal Mayor of Baliwag, hereby order the creation of a Holy Week Inter-Agency Committee.

- 2.1 Meet and discuss the details of the programs and schedules of Church activities, as well as the traffic routes and rerouting schemes during the last week of Lent;
- 2.2 Deliberate on issues and concerns that may arise and recommend measures that will ensure a safe, peaceful and meaningful observance of Holy Week;
- 2.3 Coordinate and ensure the availability of all logistic, communications, and other requirements that will be needed for an organized implementation of the programs and activities;




2.4 Other tasks deemed necessary for the completion of the objectives.

**SECTION 3. REPEALING CLAUSE.** All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and or modified accordingly.

**SECTION 4. SEPARABILITY CLAUSE.** If, for any reason or reasons, any part or provision of this Act shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be in full force and effect.

**SECTION 5. EFFECTIVITY CLAUSE.** This Executive Order shall take effect immediately.
