## TECHNICAL WORKING GROUP ON THE ISSUANCE OF THE CERTIFICATE OF ELECTRICAL INSPECTION (CEI)

WHEREAS, the Certificate of Final Electrical Inspection (CFEI) is a necessary document issued by the municipality which should be submitted to the MERALCO to ensure that electrical wirings were inspected and found to be compliant with the provisions of the Philippine Electrical Code and other applicable government rules and regulations;

WHEREAS, due to the limitation on the security features and procedures, cases of CEI falsification have been recorded jointly by the MERALCO and the Local Government Unit of Baliwag;

WHEREAS, to be able to develop a tracking and information system for a fast reliable, and convenient system of application for a certificate of electrical inspection, the immersion of electronic system shall be applied;

WHEREAS, there is a need to create a technical working group that will spearhead the enhancement of CEI issuance procedures;

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

SECTION 1.CREATION. There shall be a technical working group on the issuance of the Certificate of Electrical Inspection (CEI)

- e. Other tasks necessary and desirable in the full implementation of the policy.

SECTION 3. REPEALING CLAUSE.All previous executive orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly.

SECTION 4. EFFECTIVITY. This order shall take effect immediately.
