### ADMINISTRATIVE ORDER no. 5

#### SEPTIC TANK INSPECTION - TECHNICAL WORKING GROUP (STI-TWG)

WHEREAS, the Municipality of Baliwag, Bulacan aims to establish an environment with clean water;

WHEREAS, the Municipality of Baliwag, Bulacan wants that the Baliwagenyos have access to proper sanitation and improved water quality;

WHEREAS, the Municipality of Baliwag, Bulacan wants to end the economic losses and damage to the ecosystem and biodiversity because of lack of sewage treatment systems;

WHEREAS, for the Septic Tank Inspection to be implemented, the Municipality needs to designate a Technical Working Group to spearhead its implementation.

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

**Section 1.** There shall be a Septic Tank Inspection - Technical Working Group. (STI-TWG) shall be composed of:

**Section 2.** Powers and Functions. The Septic Tank Inspection - Technical Working Group (STI-TWG) shall:

- a. Ensure the successful implementation of Septic Tank Inspection at the local level.
- b. Cause the planning and development of a sanitation program in response to local needs.
- c. Prepare minutes of meetings and resolutions of the STI-TWG.
- d. Prepare monitoring reports of the progress and needs of the implementation.
- e. Recommend the procurement of necessary equipment, tools and materials.
- f. Other tasks necessary and desirable in the full implementation of the Septic Tank Inspection.

**Section 3.** Repealing Clause. All previous executive orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly.

**Section 4.** Effectivity. This order shall take effect immediately.
