ADMINISTRATIVE ORDER NO. 006 S. 2018

**DESIGNATING P/SUPT. MARLON R. SANTOS AS COMMANDER OF THE INCIDENT
COMMAND SYSTEM FOR OPLAN KALULUWA 2018**

WHEREAS, Sections 4 and 5 of the 1987 Philippine Constitution articulates that “it is the prime duty of the government to serve and protect the people; and that the maintenance of peace and order, the protection of life, liberty, and property, and promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy”;

WHEREAS, The Local Government Code of 1991, Chapter II Section 16 states that, Local Government Units shall ensure and support the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support the development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order, and preserve the comfort and convenience of their inhabitants;

WHEREAS, Executive Order No.42 S. 2016 created an Incident Command System to provide the functions and responsibilities of key players to ensure the role of the LGU in providing a systematic way of handling emergencies and disasters;

WHEREAS, there is a need to designate an Incident Commander who will spearhead the implementation of the Incident Action Plan and ensure that adequate safety measures are in place for the observance of the All Saints’ Day and All Souls’ Day 2018;

WHEREAS, P/Supt. Marlon R. Santos is competent and qualified for the position as the Commander of the Incident Command System

NOW THEREFORE, by the powers vested in me by law, I, **FERDINAND V. ESTRELLA**, Municipal Mayor of Baliwag, hereby order the designation of **P/SUPT. MARLON R. SANTOS** as the Commander of the Incident Command System for Oplan Kaluluwa 2018 with the following provisions.

SECTION 1. POWERS AND FUNCTIONS OF THE INCIDENT COMMANDER


- 1.1 Responsible for the over-all management response operations and determines incident objectives and strategies for Oplan Kaluluwa 2018;
- 1.2 Has the over-all authority and responsibility for conducting incident operations and establishing the Incident Command Post;
- 1.3 Establish a centralized and coordinated incident action plan that would guide all members of the Incident Command System;
- 1.4 Establish the chain of command to provide an orderly manner to manage and implement strategies to accomplish the objectives; and
- 1.5 Communicate the over-all incident priorities, objectives, strategies and tactics to ensure a peaceful, safe and orderly observance of All Saints' Day and All Souls' Day

SECTION 2. REPEALING CLAUSE. All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and or modified accordingly.

SECTION 3. SEPARABILITY CLAUSE. If, for any reason or reasons, any part or provision of this Act shall be declared unconstitutional or invalid, other parts or provisions not affected thereby shall continue to be in full force and effect.


SECTION 4. EFFECTIVITY CLAUSE. This Executive Order shall take effect immediately.
