CREATION OF THE TECHNICAL WORKING GROUP (TWG) FOR THE AMENDMENT OF
THE ORDINANCES AND IMPLEMENTING RULES AND REGULATION (IRR) ON STRAY
DOGS AND CATS

WHEREAS, Republic Act No. 10631 Sec. 6 states that it shall be unlawful for any person to torture any animal, to neglect, to provide adequate care, sustenance of shelter, or maltreat any animal or to subject any dog or horse to dogfights or horse fights, kill or cause or procure to be tortured or deprived of adequate care, sustenance or shelter, or maltreat or use the same in research or experiments not expressly authorized by the Committee on



Technical Working Group


- a. To conduct of the current implementing rules and regulations and ordinances for the stray dogs and cats of the Municipal Government of Baliwag;

- c. Ensure that funds are allocated by the LGU to augment the corresponding issue on these stray animals;
- d. To cause the enactment of additional local ordinances to support the program.
- e. To ensure that the rules and regulations for the stray dogs and cats will be for the responsible pet ownership.



SECTION 3. REPEALING CLAUSE. All orders, issuances and memorandum issued inconsistent herewith are hereby repealed and/ or modified accordingly.


SECTION 4. EFFECTIVITY CLAUSE. This administrative order shall take effect immediately.
