ADMINISTRATIVE ORDER NO. DI6 S. 2019

**AN ORDER DESIGNATING MR. RODRIGO B. TORRES AS THE FOCAL PERSON OF THE PUBLIC ORDER AND PUBLIC SAFETY PLAN OF THE MUNICIPALITY OF BALIWAG**

WHEREAS, the Municipal Peace and Order Council (MPOC) was created pursuant to Section 116 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991 and Executive Order No. 773 Series of 2009;

WHEREAS, one function of the MPOC is the formulation of the Peace and Order and Public Safety (POPS) Plan, to be incorporated in the Comprehensive Development Plan (CDP);

WHEREAS, the POPS Plan is a 3-year term bases plan which shall be incorporated in the Comprehensive Development Plan of the Local Government Unit. It is to be formulated and approved by the Peace and Order Council to improve life in the communities by ensuring social protection and safety in the locality;

WHEREAS, designation of a competent person to coordinate in the preparation, formulation and creation of the POPS Plan is vital;

NOW THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor of the Municipality of Baliwag, by the virtue of the powers vested in me by law, do hereby order the following:

**SECTION 1.** Mr. Arvy B. Torres is hereby designated as the Point Person for the coordination, preparation and documentation in the creation of Public Order and Public Safety (POPS) Plan of the Municipality of Baliwag.

**SECTION 2. DUTIES AND FUNCTIONS.** The following are the duties and functions to wit:

1. Gather data deemed necessary in regard to the implementation of POPS Plan.
2. Be responsible in encoding, uploading, reporting, and other activities related to the POPS Plan.
