EXECUTIVE ORDER No. 032 s. 2020

COMMUNITY-BASED MONITORING SYSTEM TEAM (CBMS TEAM)

WHEREAS, the Philippine Constitution mandates that the State shall promote the general welfare of the People;

WHEREAS, Section 16 of the Local Government Code of 1991 provides that the local government units shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare;

WHEREAS, in order for the Municipality of Baliwag, Bulacan to come up with scientific socio-economic plans and programs to better serve its constituents and to arrive at informed decisions particularly in local planning, program implementation and impact monitoring, the Municipality needs to have an organized process of data collection and processing which is Community Based Monitoring System;

WHEREAS, for the Community Based Monitoring System to be implemented, the Municipality needs to designate a team to spearhead its implementation.

NOW, THEREFORE, I, FERDINAND V. ESTRELLA, Municipal Mayor, Municipality of Baliwag, Bulacan, by virtue of the powers vested in me by law, do hereby order:

Section 1. There shall be Community Based Monitoring System Team (CBMS Team). The CBMS Team shall be composed of:


Section 2. Powers and Functions. The CBMS Team shall:

- a. Ensure the successful implementation of CBMS at the local level for efficient and effective collection and storage of demographic data.
- b. Recommend the designation of enumerators, facilitators, field editors and other personnel needed to fully implement CBMS.
- c. Cause the processing, evaluation and validation of data.
- d. Prepare monitoring reports of the progress and needs of the implementation.
- e. Recommend the procurement of necessary equipment, tools and materials.
- f. Other tasks necessary and desirable in the full implementation of CBMS.


Section 3. Repealing Clause. All previous executive orders and issuances which are inconsistent herewith are hereby repealed or modified accordingly

Section 4. Effectivity. This order shall take effect immediately.
