EXECUTIVE ORDER NO. 39 S. 2020

**ESTABLISHING THE LOCAL VERIFICATION COMMITTEE (LVC)**

**WHEREAS**, Executive Order, No. 867 S. 2010 of the President, the DSWD as the coordinator of the National Social Welfare Program conceptualized the National Household Targeting System for Poverty Reduction (NHTS-PR) or Listahanan to establish a system of identifying who and where the poor households are, shall maintain the system and serve as the repository of the data on poor households, which shall be used by NGAs in prioritizing beneficiaries of government's social protection programs and projects which shall update the data every four (4) years;

**WHEREAS**, a letter from the Department of Social Welfare and Development was received by the Municipality requesting the creation of the Local Verification Committee which supports the DSWD in attaining accuracy in the validation and finalization phase for 2<sup>nd</sup> semester of calendar year 2020;

**WHEREAS**, the Municipality of Baliwag knows acknowledges the need in establishing the Local Verification Committee and its positive attributes;

**NOW, THEREFORE, I, FERDINAND V. ESTRELLA**, Local Chief Executive of the Municipality of Baliwag, by virtue of powers vested upon me by law do hereby order the **ESTABLISHMENT OF THE LOCAL VERIFICATION COMMITTEE**:

**SECTION 1. COMPOSITION.** The LVC shall be composed of the following:

**SECTION 2. FUNCTIONS.** The LVC shall have the following functions:

- 2.1 Resolve all complaints and/ or appeals brought by individuals and/ groups;
- 2.2 Identify households that have not been assessed; and
- 2.3 Certify the completeness and incompleteness of the list of households living below the poverty threshold along with the recommended changes.

**SECTION 3. BARANGAY VERIFICATION TEAM (BVT).** There shall be a BVT organized through a Barangay Resolution or Ordinance to assist in the overall validation process and shall be primarily responsible in the objective review of appeals and grievances from the community.

**3.1 COMPOSITION.** The BVT shall be composed of:


- a. The Punong Barangay or his/her duly authorized representative;
- b. First Kagawad;
- c. Kagawad-in-charge of Social Services/Welfare; and
- d. A representative from a civil society organization (CSO) operating in the barangay (if applicable)

**SECTION 4. REPEALING CLAUSE.** All orders, local issuances, or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**SECTION 5. SEPARABILITY CLAUSE.** If for any reason, any provision of this Order is declared unconstitutional or invalid, the remaining provisions not affected thereby shall continue to be in full legal force and effect.


**SECTION 6. EFFECTIVITY CLAUSE.** This Order shall take effect immediately.
